Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: Title 35.II.2.12 Title 35.II.2.12 - Tied House, Gifts, Gratuities and Inducements is amended to clarify that a holder or its promotional representative may furnish to off-premises retailers rebates or coupons that are redeemable either via mail or online by the holder. Other minor changes were made.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(h), "To adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders, not inconsistent with this chapter or any law of this state or of the United States, as it deems necessary to control the manufacture, importation, transportation, distribution and sale of alcoholic liquor, whether intended for beverage or nonbeverage use in a manner not inconsistent with the provisions of this chapter or any other statute, including the native wine laws."
