General fund transfers by the Department of Revenue for the 7th month of the fiscal year ending June 30, 2018 were \$388,988,312 which is an increase of \$18,107,624 or 4.88% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending January 31, 2018 were \$2,891,492,466 which is an increase of \$104,611,806 or 3.75% from the same period of the prior year.

Transfers to all funds in the month of January for the fiscal year ending June 30, 2018 were \$563,101,831 which is an increase of \$6,445,206 or 1.16% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending January 31, 2018 were \$4,242,419,631 which is an increase of \$60,337,200 or 1.44% from the same period of the prior year.
