Mississippi TELEFILE INSTRUCTIONS

1. TeleFile allows you to file your income tax by telephone (**Touch-Tone Only**). Please check the boxes below to see if you qualify to file by TeleFile:

- Resident of Mississippi with Mississippi income only.
- Filing Status of Single or Married-Combined or Joint Return.
- Same Taxpayer names, social security number, and filing status as prior year.
- No dependents.
- Wages and interest income only.
- No more than six (6) W-2 forms per return.
- Total income from salaries, wages, tips, etc. less than \$100,000.
- A Mississippi address which is the same as last year.
- Must use Standard Deduction

Attach W2s & 1099s Here

If you were not able to check **ALL** the boxes above, you do not qualify to file by TeleFile. However, you may be able to file using the EZ Individual Income Tax Return (Form 80-110).

If you qualify to file TeleFile, continue with the instructions below for filing by telephone:

1. PREPARE
 - A. Get all W-2 form(s) and 1099-INT(s) together.
 - B. Locate the TeleFile Worksheet on Page 2 of the tax booklet.
 - C. Sharpen your pencil.
2. Dial the toll-free Telefile number: 1-800-680-1589 (Jackson Residents: 923-7810).
3. Follow the instructions when asked by TELEFILE.
4. Keep the TeleFile Worksheet you completed during the call. **DO NOT** send it to the State Tax Commission.
5. Complete the TELEFILE SIGNATURE DOCUMENT (Form 80-120), on the reverse side of this page. Attach the state copy of Form W-2(s) and sign in the signature area.
6. SEND the TELEFILE SIGNATURE DOCUMENT to the appropriate address below:
