



**2004 Mississippi Resident TELEFILE Forms and Instructions**

**You may be able to file your Mississippi Resident income tax return by telephone. TeleFile is available for single taxpayers with no dependents or married taxpayers filing joint or combined returns who meet certain qualifications. *BY FILING YOUR RETURN USING THE PHONE YOU GAIN CONVENIENCE, ACCURACY, AND A FASTER REFUND.***

**You may file your income tax by TeleFile if you meet ALL of the following qualifications:**

- ... Resident of Mississippi with Mississippi income only**
- ... Filing Status of Single or Married-Combined or Joint Return**
- ... Same Taxpayer names, social security number, and filing status as prior year**
- ... No Dependents**
- ... Wages and interest income only**
- ... No more than six (6) W-2 forms per return**
- ... Total income from salaries, wages, tips, etc. less than \$100,000**
- ... A Mississippi address which is the same as last year**
- ... Must use Standard Deduction**

**If you do not meet ALL of the above qualifications, you do not qualify to file by TeleFile. However, single taxpayers may be able to file using the EZ Individual Income Tax Return (Form 80-110). An EZ Return, or other individual income tax return, may be obtained by contacting the nearest State Tax Commission District Office listed on page 2.**

**If you qualify to file TeleFile, follow the instructions shown on page 2. YOU MUST USE A TOUCH-TONE TELEPHONE.**

The Following Mississippi TeleFile Worksheet is furnished to assist you in completing your TeleFile call and preparing the TeleFile Signature Document, Form 80-120, which MUST BE SIGNED AND RECEIVED BY THE STATE TAX COMMISSION before a complete return is considered filed.

**Mississippi TeleFile Worksheet**

TeleFile is available for Married-Filing Joint or Combined Return or Single Taxpayers. TeleFile will ask for your wages and Mississippi income tax withheld from each W-2 separately. TeleFile will ask you for a total interest income amount. Make sure you have all W-2's and interest income information from all sources in 2004.

- Complete the TELEFILE SIGNATURE DOCUMENT (Form 80-120) enclosed. Attach the state copy of Form W-2(s) and sign in the signature area. If a joint return is filed, both spouses must sign the document.
