## Key to Individual Income Tax Declaration for On-Line Electronic Filing

The form number is 80-115-05.

This form is retained by the electronic return originator. It does not require barcodes or registration marks. This form is a supporting schedule for the Individual Income Tax return. This form should be a reasonable reproduction of the example provided, but small variations are acceptable. This form must be approved by the Mississippi Tax Commission.

Any amounts in the form should be rounded and show whole dollars only.
