Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This rule was amended to define "sales of the business" in paragraph 100, and to include a fourth category of sales records that restaurants must keep called "all other sales". The four categories are: food, beer, alcoholic beverages and all other sales. Various other changes were made as well.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(k), "To inspect, or cause to be inspected, any premises where alcoholic liquors intended for sale are manufactured, stored, distributed or sold, and to examine or cause to be examined all books and records pertaining to the business conducted therein."
