Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule was amended to combine the first sentence in paragraph 102 with paragraph 100, thereby eliminating unnecessary duplication. Paragraph 106 was amended to clarify that books and other property given to the family of the deceased are taxable to the funeral home at the regular retail rate of tax on the purchase price. Other minor changes were made.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-65-93, "(1) The commissioner shall, from time to time, promulgate rules and regulations, not inconsistent with the provisions of the sales tax law, for making returns and for the ascertainment, assessment and collection of the tax imposed by the sales tax law as he may deem necessary to enforce its provisions."
