Checklist for Direct Wine Shipper's Permit

Direct Wine Shipper permit applications are available via [TAP](#).

Before applying for a permit you will need to:

- Register for a **Mississippi Sales or Use Tax** account and receive a sales or use tax permit via TAP

The following information must accompany an application for REVIEW. If all of this information is attached, your application will be considered COMPLETED.

For in state entities,

- ☐ Legal name of business, mailing address and physical address of the facility where wine is produced and fulfilled
- ☐ Proof of Mississippi Secretary of State Registration
- ☐ Mississippi Sales Tax permit
- ☐ Mississippi Class 2 or Class 3 Manufacturer's permit
- ☐ Itemized product listing of items intended for sale through direct shipment including brand, unit size, and SKU with attached TTB approved COLA
- ☐ Waiver and Authorization to Release Information Form*
- ☐ Permittee Certification/Oath*
- ☐ Acknowledgement that applicant will only sell products that are not offered by ABC Warehouse except available allocated items
- ☐ Acknowledgement that applicant will only sell wine as defined in 67-1-5 for shipment in Mississippi.
- ☐ Acknowledgement that any containers of wine sold and shipped by a direct wine shipper to a resident into or within this state will be conspicuously labeled with the words "CONTAINS ALCOHOL; SIGNATURE OF PERSON AGE 21 YEARS OR OLDER REQUIRED FOR DELIVERY in lettering that is bold and that contrasts with packaging.
- ☐ Acknowledgement that applicant understands that signature of shipments must be made by a person who has demonstrated that they are 21 years of age or older.
- ☐ Permittee Contact Information
- ☐ Permit fee of \$100

For out of state entities,

- ☐ Legal name of business, mailing address and physical address of the facility where wine is produced and fulfilled
- ☐ Proof of Good Standing from state of domicile
- ☐ Mississippi Use Tax permit
- ☐ Current state issued wine manufacturers' permit or license or wine fulfillment provider's permit or license

- ☐ Itemized product listing of items intended for sale through direct shipment including brand, unit size, and SKU with attached TTB approved COLA
- ☐ Waiver and Authorization to Release Information Form*
- ☐ Permittee Certification/Oath Form*
- ☐ Acknowledgement that applicant will only sell products that are not offered by ABC Warehouse except available allocated items
- ☐ Acknowledgement that applicant will only sell wine as defined in 67-1-5 for shipment into Mississippi.
- ☐ Acknowledgement that any containers of wine sold and shipped by a direct wine shipper to a resident into or within this state will be conspicuously labeled with the words "CONTAINS ALCOHOL; SIGNATURE OF PERSON AGE 21 YEARS OR OLDER REQUIRED FOR DELIVERY in lettering that is bold and that contrasts with packaging.
- ☐ Acknowledgement that applicant understands that signature of shipments must be made by a person who has demonstrated that they are 21 years of age or older.
