

Mississippi Petroleum Tax Rates

Last Revision: April 2025

State Petroleum Taxes

Automotive Gasoline will increase as follows:

Period	Excise Tax Rate Per Gallon
Through June 30, 2025	18 cents
July 1, 2025 through June 30, 2026	21 cents
July 1, 2026 through June 30, 2027	24 cents
July 1, 2027 forward	27 cents

Aviation Gasoline.....6.4 Cents Per Gallon

Undyed Diesel Fuel will increase as follows:

Period	Excise Tax Rate Per Gallon
Through June 30, 2025	18 cents
July 1, 2025 through June 30, 2026	21 cents
July 1, 2026 through June 30, 2027	24 cents
July 1, 2027 forward	27 cents

Dyed Diesel Fuel.....5.75 Cents Per Gallon

Jet Fuel.....5.25 Cents Per Gallon

Beginning July 1, 2029, and July 1 of every other year thereafter, the excise tax rates on fuels may be adjusted with a maximum increase of 1 cent per gallon per year. The adjustment is based on the percentage change in the yearly average of the National Highway Construction Cost Index (NHCCI). The following excise taxes are subject to these rate changes beginning July 1, 2029:

- Automotive Gasoline
- Aviation Gasoline
- Undyed Diesel
- Dyed Diesel
- Kerosene
- Fuel Oil
- Jet Fuel

Lubricating (Motor) Oil.....8 Cents Per Gallon

Compressed Gas (Butane, Propane etc.)35/100 Cents Per Gallon

Compressed Gas (Butane, Propane etc.) Highway Use	17 Cents Per Gallon
Compressed or Liquefied Natural Gas – Highway Use.....	18 Cents Per CCF
Natural Gas Used in Oilfield or Gasfield Production Pumps.....	12 Cents Per MCF
Compressed Gas (Butane, Propane etc.) Used in Oilfield Or Gasfield Production Pumps.....	2 Cents Per Gallon
Natural Gas Used in Pipeline Compressors.....	3 Cents Per MCF
Compressed Gas (Butane, Propane etc.) Used in Pipeline Compressors.....	1/2 Cent Per Gallon
Railroad Locomotive Fuel (Diesel Fuel).....	3/4 Cent Per Gallon
Environmental Protection Fee (Automotive Gasoline, Aviation Gasoline, Diesel Fuel, Kerosene, Fuel Oil & Jet Fuel).....	4/10 Cent Per Gallon

Local Taxes:

Harrison.....	3 Cents Per Gallon
Jackson.....	3 Cents Per Gallon

Automotive Gasoline.....	5.4 Cents Per Gallon
Aviation Gasoline.....	5.4 Cents Per Gallon
Undyed Diesel Fuel.....	4.75 Cents Per Gallon
Dyed Diesel Fuel.....	4.75 Cents Per Gallon
Jet Fuel.....	4.75 Cents Per Gallon
Butane, Propane etc.....	3.0 Cents Per Gallon
Compressed or Liquefied Natural Gas.....	3.0 Cents Per CCF
