Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule was amended to correct a citation in Paragraph 109 and to relocate a paragraph in paragraph 201 for clarity. New paragraphs 202 and 204 were added to clarify the definition of a "restaurant" from Miss. Code Ann. Section 67-1-5(m)(i) where 25% of the revenue of a business must come from meals or the value of food consumed by customers and to provide two methods to calculate the requirement. Paragraph 203 was added to provide a definition for "meals". Other minor changes were made.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(h), "To adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders, not inconsistent with this chapter or any law of this state or of the United States, as it deems necessary to control the manufacture, importation, transportation, distribution and sale of alcoholic liquor, whether intended for beverage or nonbeverage use in a manner not inconsistent with the provisions of this chapter or any other statute, including the native wine laws."
