Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This rule was amended to include various minor changes to increase the understanding and the readability of the rule. Paragraph 100 was separated into new paragraphs 101 and 102, with 101 focusing on when alcohol can be sold on New Year's Eve. Paragraph 102 and 103 were reorganized and rephrased. The title of the reg was updated to include "on-premises permittees", which includes, "hotels", "restaurants" and "clubs". Various other changes were made as well.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(m), "To designate hours and days when alcoholic beverages may be sold in different localities in the state which permit such sale."
