Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule was amended to include "Tied House" in the title and to add a definitions section in Paragraphs 100 – 107. These definitions are added to increase the understandability of the rule. In paragraphs 200 and 202, a holder giving or selling product displays, equipment or supplies to a retailer is addressed. Paragraphs 209 and 210 clarify that a permittee can use loyalty cards under certain circumstances. Other minor changes were made.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(h), "To adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders, not inconsistent with this chapter or any law of this state or of the United States, as it deems necessary to control the manufacture, importation, transportation, distribution and sale of alcoholic liquor, whether intended for beverage or nonbeverage use in a manner not inconsistent with the provisions of this chapter or any other statute, including the native wine laws."
