Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule originally stated that long term contracts entered into after February 28, 1986 must be reported using the percentage of completion method as required by the IRS. The passage of the Tax Cut and Jobs Act changed when contractors must use the percentage of completion method. The percentage of completion method should be used when a contractor has annual gross receipts over twenty five million dollars for the last three years or has any general construction projects that will take more than two years to complete. This rule is amended to state that the Department will follow federal rules, regulations and revenue procedures relating to contractors.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-7-331, "The commissioner shall also make and prescribe such other rules, regulations and forms as he shall deem necessary or desirable for carrying out the purposes of this article". This rule change is in conformity with Miss. Code Ann. Section 27-7-81.

List all rules repealed, amended, or suspended by the proposed rule: Miss. Admin Code Title 35.III.1.08 Contractors.

At any time within the twenty-five (25) day public comment period, written submissions including arguments, data, and views on the proposed rule/amendment/repeal may be submitted to the filing agency.
