Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule was amended to add citations in new paragraphs 100 and 101. Paragraph 101 was updated to more closely reflect the language in the law. The rule was amended for other minor changes. The phrase ""and pay "common and contract carriers of property" privilege tax"" was added to the end of paragraph 104 after the oral proceeding. This is considered a nonsubstantive change.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-19-121, "The State Tax Commission is hereby given power and authority to make all rules and regulations, not inconsistent with the provisions of this article, as will, in the judgment of the commission, contribute to a more efficient administration of this article."
