Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Any language that was found in statute was deleted to reduce unnecessary duplication in the rule. The definition of a "full time employee" was moved to new paragraph 100 and amended to include a minimum of 35 hours per week. Old paragraph 203 was moved above new paragraph 102. The rule was renamed as well to "Misuse of Dealer Permit".

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-19-121, "The State Tax Commission is hereby given power and authority to make all rules and regulations, not inconsistent with the provisions of this article, as will, in the judgment of the commission, contribute to a more efficient administration of this article."

List all rules repealed, amended, or suspended by the proposed rule: Miss. Admin Code Title 35.VII.4.01 Motor Vehicle Dealer Permit.
