Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This rule was amended to update paragraph 100 for the current process of obtaining and submitting the "Power of Attorney to Transfer Motor Vehicle" form. The sentence that made up Title 35.VII.4.08 Power of Attorney – Assignment of, was reworded and included as paragraph 101 in Title 35.VII.4.06 Power of Attorney to Transfer Motor Vehicle. The rule was renamed as well.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-19-121, "The State Tax Commission is hereby given power and authority to make all rules and regulations, not inconsistent with the provisions of this article, as will, in the judgment of the commission, contribute to a more efficient administration of this article."
