Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule is amended to correct a citation, to clarify paragraph 100, and to include where different weights of motor vehicles should be registered in paragraph 101 per Miss. Code Ann. Sections 27-19-43(1), 27-19-63(2) and 27-19-66. It was also amended for other minor changes. Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-19-121, "The State Tax Commission is hereby given power and authority to make all rules and regulations, not inconsistent with the provisions of this article, as will, in the judgment of the commission, contribute to a more efficient administration of this article." List all rules repealed, amended, or suspended by the proposed rule: Miss. Admin Rule 35.VII.3.03 Where to Register Vehicles.
