Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This rule is amended to combine Title 35.VII.4.15 Revocation of Designated Agent Status with Title 35.VII.4.02 Revocation of Designated Agent Authority. Miss. Code Ann. Section 63-21-13 provides that a motor vehicle dealer shall be a designated agent. If the motor vehicle dealer's designated agent status is revoked for cause, the dealer permit is likewise revoked.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-19-121, "The State Tax Commission is hereby given power and authority to make all rules and regulations, not inconsistent with the provisions of this article, as will, in the judgment of the commission, contribute to a more efficient administration of this article."

List all rules repealed, amended, or suspended by the proposed rule: Miss. Admin Rule 35.VII.4.02 Revocation of Designated Agent Authority.
