Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Title 35.VII.4.15 Revocation of Designated Agent Status is no longer needed. The Department has moved the relevant part of the regulation explaining that the designated agent status may be revoked if the duties imposed by the law are not performed or for other good cause. It has been moved to Title 35.VII.4.02 Revocation of Designated Agent Authority. This Chapter is being reserved to renumber the Subpart at a later date.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-19-121, "The State Tax Commission is hereby given power and authority to make all rules and regulations, not inconsistent with the provisions of this article, as will, in the judgment of the commission, contribute to a more efficient administration of this article."
