Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule replaces old Title 35, Part XI, Chapter 21 Sales Limits, paragraph 100, to provide for a rolling seven-day period when calculating the 6 MMCEU limit per cardholder. "Rolling" shall be calculated by reviewing the previous six days.
