Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Title 35.II.2.25 Alcohol Delivery is amended to clarify that the Division will no longer approve scanning software used on a recipient's identification to confirm that a recipient is over the age of 21.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(h), "To adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders, not inconsistent with this chapter or any law of this state or of the United States, as it deems necessary to control the manufacture, importation, transportation, distribution and sale of alcoholic liquor, whether intended for beverage or nonbeverage use in a manner not inconsistent with the provisions of this chapter or any other statute, including the native wine laws."
