The Mississippi Department of Revenue (referred to as "DOR" or "Department") solicited bids for **Print on Demand Road and Bridge Registration Receipt with Attached Decal** for a turnkey solution for producing vehicle registration forms with validation stickers at each of the Tax Collector's offices throughout the State. These forms with validation stickers are expected to print at the time of sale to taxpayers. This system is designed to eliminate the requirements for maintaining large quantities of pre-printed validation stickers and separate road and bridge registration receipt forms. The expiration date for this service is July 31, 2030.

DOR will contract for these services with a single vendor for a term of sixty (60) months.

DOR released the Print on Demand Road and Bridge Registration Receipt With Attached Decal Invitation for Bid (IFB) # 3160007231 on March 5, 2025. DOR received one (1) bid submitted via MAGIC in response to this IFB. The bid was submitted by the following bidder:

• Intellectual Technology, Inc.

The bid submitted by Intellectual Technology, Inc was evaluated and deemed responsive and responsible according to the criteria stated in the solicitation and was, therefore, ranked the highest.

We announce our recommendation to award a contract to the following vendor subject to approval by the Mississippi License Tag Commission.

We invite you to contact **Nyla Kendrick, Procurement Officer,** if you would like to request a post-award vendor debriefing under Section 7-113 of the PPRB OPSCR Rules and Regulations. This debriefing is a meeting and not a hearing; therefore, legal representation is not required. However, if you prefer to have legal representation present, you must provide notification prior to the scheduled meeting so that we can also have legal representation present. Your request for debriefing must be received within three (3) business days after the issuance of this notice or no later than **May 15, 2025**. MDOR reserves the right to conduct any such debriefing via a teleconference.

Vendors are reminded that any protests of this decision must be submitted to **Nyla Kendrick**, **Procurement Officer** within seven (7) calendar days after the issuance of this notice or no later

than May 20, 2025. The protest must be in writing, identify the name and address of the protestor, provide appropriate identification of the procurement and resulting contract number (if known), and detail the nature of the protest, including available supporting exhibits, evidence, or documents to substantiate any claims.

The successful vendor is instructed not to begin work, purchase materials, or enter into subcontracts relating to the project or services until execution of the contract.
