General fund transfers by the Department of Revenue for the 11th month of the fiscal year ending June 30, 2023 were \$560,046,216 which is a decrease of -\$94,115,598 or -14.39% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending May 31, 2023 were \$6,692,657,872 which is an increase of \$248,045,631 or 3.85% from the same period of the prior year.

Transfers to all funds in the month of May for the fiscal year ending June 30, 2023 were \$851,464,508 which is a decrease of -\$78,831,831 or -8.47% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending May 31, 2023 were \$9,850,933,367 which is an increase of \$454,068,426 or 4.83% from the same period of the prior year.
