#### **Mississippi Department of Revenue** Summary of Transfers June 2025

General fund transfers by the Department of Revenue for the 12th month of the fiscal year ending June 30, 2025 were \$770,801,386 which is an increase of \$16,417,879 or 2.18% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending June 30, 2025 were \$7,230,820,230 which is a decrease of -\$111,771,728 or -1.52% from the same period of the prior year.

Transfers to all funds in the month of June for the fiscal year ending June 30, 2025 were \$1,032,206,891 which is an increase of \$14,451,600 or 1.42% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending June 30, 2025 were \$11,024,436,928 which is an increase of \$51,027,106 or .47% from the same period of the prior year.
