Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This rule was rephrased for clarity and has been limited to addressing an employee of the Alcoholic Beverage Control by eliminating any mention of the permittee. Information pertaining to the interests of permittees can be found in Miss. Admin. Code Title 35.II.3.02 Permit Limit and Miss. Admin. Code Title 35.II.3.05 Permit Transfer. Other minor changes were made.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 67-1-37(h), "To adopt and promulgate, repeal and amend, such rules, regulations, standards, requirements and orders, not inconsistent with this chapter or any law of this state or of the United States, as it deems necessary to control the manufacture, importation, transportation, distribution and sale of alcoholic liquor, whether intended for beverage or nonbeverage use in a manner not inconsistent with the provisions of this chapter or any other statute, including the native wine laws."
